#### **EXHIBITOR INSURANCE/HOLD HARMLESS CLAUSE**

Exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, defend, save and hold harmless the International Workers' Compensation Foundation (IWCF), its members, employees and agents, Chelsea Place Meetings and its employees and agents, and the Sheraton Gateway Hotel/Oakland Marriott City Center against all claims, losses and damages to persons or property, governmental charges or fines and attorney fees arising out of or caused by exhibitor's installation, removal, maintenance, occupancy or use of the exhibition premises or part thereof, excluding any such liability caused by the sole negligence or concurrent comparative negligence of the Sheraton Gateway Hotel/ Oakland Marriott City Center and their employees and agents, Chelsea Place Meetings and its employees and agents, as well as the IWCF, its members, employees and agents.
